5. Noting that the student's name will be removed off the official school lists in case of failure to comply with the stated registration deadlines.						
6. Noting that all fees are fixed and may not undergo any form of discount. ZSIS Staff Members are the only ones entitled for a discount that is cancelled as soon their contract is terminated for any reason.						
7. Informing the school about our wish to withdraw our child's file during the current registration period. That is for attesting all papers required.						
8. In case of student file withdrawal <u>after the beginning of the academic year during a period of 15 days or less, we will be entitled to complete 20% of the total tuition fees.</u>						
9. In case of student file withdrawal <u>after the beginning of the academic year during a period that exceeds 15 days and before the beginning of the 2<sup>nd</sup> Term, we will be entitled to complete 50% of the total tuition fees.</u>						
10. In case of student file withdrawal after the beginning of the 2 <sup>nd</sup> Term, we will be entitled to complete the tuition fees for the full school year.						
11. In case of the student's failure to show up during the first week of school without an official notice by the guardians or parents, the student's registration will be cancelled and noting that the fees are non-refundable.						
12. In case of registration for the 2 <sup>nd</sup> School Term, 50% of the total tuition fee is to be paid.						
13. The Administration has the full right to retain the Student's File and Report Card in case of the failure to complete the fee installments as scheduled. Hereby, I do not have the right to request any access to the aforementioned documents before completing the full payment.						
14. The Registration Contract is renewed on yearly basis.
